- Applicants must fall under the category of Corporate Meetings and Incentive Travel. Incentive travel is
 defined by the Society for Incentive Travel Excellence (SITE) as:
 Incentive groups are defined by SITE (Society of Incentive Travel Executives) as a global management tool
 that uses an exceptional travel experience to motivate and/or recognize participants for increased levels of
 performance in support of organizational goals.
- Applicants must be registered and recognized as a Corporate company, Incentive House, Destination Management Company (DMC), Corporate Travel Agent (CTA), or Event Management Company (EMC).
- Completed application must be **received by Malaysia Convention & Exhibition Bureau (MyCEB) no** later than 30 working days prior to the event date.
- Application submitted to MyCEB in less than 30 working days, approval will be at the discretion of MyCEB's Management.
- The group must include a minimum stay of two (2) nights at a 4 or 5-star hotel in Malaysia.
- The support is **only for International delegates** (Non Malaysian delegates) and not less than 50 delegates.
- Financial support is claimable after the event's completion, with full documentation submitted within the specified timeframe stipulated in the agreement.
